By Deputation (Including Short Term Contract):

Officers employed in the Stenographic service of the departments of the Central/ State Government/ UTs/ Public Sector Undertakings/ State Electricity Boards/Autonomous Bodies :

- I(a) holding analogous post on regular basis in the parent cadre or department; or
- (b) with minimum 2 years regular service in the grade in Level-7 (Rs. 44900-142400) of the Pay Matrix or equivalent in the parent cadre or department;; or
- (c) with minimum 6 years regular service in the grade in Level -6 (Rs. 35400-112400) of the Pay Matrix or equivalent in the parent cadre or department; and

II. Possessing 12th class or equivalent from a recognized board or university with having a speed of 120 words per minute in shorthand with knowledge of computers.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (Including Short Term Contract) including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

Note 3: The Maximum age limit for appointment on deputation (Including Short Term Contract) shall be 'Not exceeding 56 years' as on the closing date for receipt of applications.
